1. Introduction

This Privacy Policy explains how USW Benefit Funds ("we," "us," or "the Trust") collects, uses, and protects your information when you opt in to receive SMS (text message) communications about your benefits.

2. Information We Collect

When you opt in to our SMS communications, we collect and store:

- Your mobile phone number
- Your name
- Your participant ID
- Date and method of consent
- Your communication preferences
- Records of text messages sent to and received from you

3. How We Use Your Information

We use your mobile number and related information solely to:

- Send you important information about your benefits
- Provide updates about your claims or coverage
- Send you reminders about deadlines or required actions
- Respond to your benefit-related inquiries
- Maintain records of our communications

4. Legal Basis for Processing

We process your information based on:

- Your explicit consent to receive SMS communications
- Our legitimate interest in administering your benefits
- Our obligation to properly manage the Trust's benefit programs

5. Protection of Your Information

We maintain appropriate technical and organizational security measures to protect your information, including:

• Encryption of stored data

We do not sell, rent, or share your mobile number or related information with third parties except:

All third-party service providers are contractually obligated to protect your information.

7. Your Rights

You have the right to:

- Withdraw consent to receive SMS communications at any time
- Request access to your personal information
- Request correction of inaccurate information
- Request deletion of your information (subject to legal requirements)
